Taught by distinguished academics and practitioners from India and abroad, the Joint Academy will equip participants with theoretical and practical insights into various issues relating to international trade law.

#### WHO CAN APPLY

- All law students enrolled in any legal course in India, either at the undergraduate or postgraduate level. Preference will be given to students who have prior exposure to issues relating to International Trade Law.
- The Joint Academy is also open to Indian legal professionals. In addition, legal professionals can attend specific modules, in a flexible, "à la carte" manner. This option is not available for students.
- The maximum number of participants that will be selected for the Joint Academy is 30 (thirty). Past participants are kindly requested not to re-apply.
- Selection of candidates is at the final discretion of the Centre.
