About the Seminar

Terrorism is not a new phenomenon in India; in fact the last decade has seen large scale terrorism across the country, major among them being the attack on parliament house, attack on J&K legislative assembly building, Akshardham Temple Attack, Malegoan blasts and the list goes on and on. However the 26/11 terrorist attacks on CSJ Railway station, hotel trident and Taj and other important places in Mumbai can be considered to be a watershed in the history of terrorism in India as it has turned into a very crucial issue of importance in Indian civilization.

Our legislature had made constant efforts to combat with terrorism in this country; the parliament has brought certain legislative enactments to tackle with the growing menace of terrorism at various levels. The criminal justice administration in India has been undertaking legislative devices for dealing with terrorism and we have had special legislations in the form of TADA and POTA during the pick of terrorism.

Therefore, it is highly necessary to discuss as to how far the existing laws in India are effective to tackle the various challenges faced by our security forces and legislators to control the terrorism and insurgency in India. The one day National Seminar on "Terrorism in India: Issues and Challenges" attempts to examine these various challenges and concerns raised by the use and misuse of anti terrorism laws.

GUIDELINES FOR SUBMISSION

All abstracts and full papers must be submitted electronically via email to dirdmails@gmail.com in the format given below:

- Registration Fee for Teachers is Rs. 500/- & for Research Scholars / Students is Rs. 300/-.
- The abstract should not be more than 350 words and must contain the following details such as Title of the Paper, Name of the Author, University/ Institution/ Organization, Email Address and Mobile Number.
- The full paper should be between 3500 - 4000 words (excluding the footnotes)
- The main text should be in Times New Roman with font size 12 and spacing of 1.5.
- All references must be in the form of footnotes. The footnotes should be in Times New Roman, font size 10 with single spacing. The authors should follow OSCOLA standard of footnoting.
- Co-authorship is allowed only upto two authors.
- All entries must be original and unpublished work of the author(s) and should not have been submitted for publication/published elsewhere in any form. Any sort of plagiarism will not be entertained.

Publication of Papers: The organizers propose to publish selected best papers of the Seminar in “DIRD RAYS”, refereed journal with ISSN Number.
