## ABOUT THE SEMINAR

The scourge of terrorism is exercising almost every country today. The growth of cross border terrorist organizations has further added to their invincibility. Terrorist organizations come in many forms, ranging from

small, underground networks to large, regional bodies. Terrorist financing is the process by which terrorists fund their operations in order to perform terrorist acts. Terrorist cells exercise several methods to raise and “clean” their money, ranging from illegal activities like organized fraud, smuggling of weapons or narcotics, and other goods, kidnapping and extortion to legitimate funding sources, including charitable organizations, personal donations, hawalas, or legitimate businesses. To replenish and expand their movements, terrorist groups engage in the process of recruiting new members. Groups like Al Qaeda and ISIL have developed extremely sophisticated internet recruitment mechanisms through social media and other platforms to recruit at-risk and troubled individuals who are susceptible to being radicalized and carry out violent acts. To sheath themselves from the impact of their nefarious activities, governments ordinarily maintain lists of terrorist organizations and have put in place specialised police authorities and defense cells to gather intelligence, trace their movements and links to arms and ammunition and to financiers that fund them. The Seminar aims to elicit and share knowledge on various aspects of terrorism. It invites case research based papers on its impact on the economy, the social fabric, the civilian peace and the efficacy of the means to handle it.
