## DAY-1 WORKSHOP ON DRAFTING OF ARBITRATION CLAUSE & LECTURES

The workshop led by international legal experts would provide best practices, on how best to draft binding and enforceable arbitration clauses in contracts. The workshop shall feature drafting exercises, case studies and a series of presentations that covers the current scenario of Indian Arbitration Law, essential elements of arbitration agreements, a comparison of arbitration institutions and procedural rules, and investor-state arbitration.

## DAY-2 PANEL DISCUSSION ON TIME & COST OF ARBITRATION & LECTURES

At a time when the legitimacy and efficacy of arbitration as a system of dispute settlement is being questioned, it is all the more important to discuss time and cost issues, analyze to what extent these concerns are warranted, pinpoint the contributing factors, and identify potential solutions. The panel consisting of various experts shall deal into the above topic followed by lecture on Sports Arbitration.

#### DAY-3 LECTURES & PAPER PRESENTATION

An interactive discussion shall be hosted by various experts on the Current Challenges in Arbitration. Paper Presentation is not mandatory, however, it is open for students who wish to present and if it has been approved by the Organizing Committee of CARDS. The Call for Papers is also attached herewith. All selected papers shall be published in our upcoming Conference Book.

#### **GUIDELINES FOR CALL FOR PAPERS**

The last date of submission of paper along with abstracts is 08/09/2017. Selection shall be made on a rolling basis.

#### Theme of the Issue – **DISPUTE RESOLUTION**

Sub Themes: Commercial Arbitration, Investment Arbitration, Sports Arbitration.

We accept submissions under the following category:

- 1. Articles 3000 4000 words (exclusive footnotes)
- 2. Research Paper 5000 7000 words (exclusive footnotes)
- 3. Short Note & Case Comment 1500 2500 words (exclusive footnotes)
- 4. Book Review 3000 5000 words (exclusive footnotes)

#### **Submission Guidelines:**

- 1. All submissions should be accompanied by an abstract of about 200 words outlining the central argument(s) of the paper.
- 2. Authors shall declare that the papers submitted for publication do not infringe the copyright of any other person. Except agreed otherwise, the copyright of the articles published shall vest with DSNLU, viz. the organizer. However, the organizers shall not be liable for any copyright infringement by the authors.
- 3. In order to facilitate anonymity, authors must mention their names, contact details and affiliations only on the cover page of the manuscript.
- 4. Plagiarism will result in the summary rejection of the submission.
- 5. Co authorship is allowed to a maximum of two authors.

#### **Formatting Guidelines:**

- 1. All Submissions must follow The Harvard Bluebook (19<sup>th</sup> edition) method of citation.
- 2. Submissions must be in Times New Roman; font size 12 (main text) & line spacing of main text should be 1.5, 1 inch margin space on both sides and justified.
- 3. All footnotes must be in Times New Roman Size 10, single spacing and justified.
- 4. Submissions must be made in. doc/.docx/.odt format.

- 5. Charts/Tables: These should be made a part of the main text itself.
- 6. Name of the author underneath the title of the submission in italics, 12 points, Times New Roman. Name and other details of the author should not appear anywhere else in the paper.
- 7. Page numbering should be in the middle of the page.
- 8. Quotations from primary sources: In italics, within inverted commas and duly acknowledged in the footnotes.

**Note:** All submissions will go through a rigorous review process and possible editing by the Editorial Board. The editorial board reserves the right to reject any final paper even after the submission and selection.

We welcome submissions from Students, Academicians, and Researchers & Legal Practitioners, to come up with their contributions in the form of articles, research papers, case comments and book reviews.
