### Registration

All teams have to register through their respective colleges. Registration of only one team will be allowed from one college. Each team shall consist of two participants.

Scanned copies of duly filled registration form along with the seal and signature of the Head of the Institution has to be sent to iihr.india@gmail.com. Deadline for registration is 30<sup>th</sup> November 2017 by 5 P.M.

Kindly note that registration <u>DOES NOT</u> mean that the team has been selected. Selection of teams will done through <u>DRAW OF LOTS</u> and 8 teams will be selected and announcement regarding the same will be made on **2**<sup>nd</sup> **December 2017** via email.

The selected participants are required to be present at the venue by 9:00 A.M. on 10<sup>th</sup> December, 2017 as the process of registration will start at 9:15 A.M. and will close at 10:30 A.M. Kindly bring the hard copies of your duly filled registration forms sealed and signed by the HODs of your respective colleges. Late entries won't be entertained.

#### Date, Time & Venue

Debate Competition will start from 1:30 P.M. to 4:30 P.M. on 10<sup>th</sup> December, 2017 at Multipurpose Hall, India International Centre, New Delhi.

### **Eligibility**

Students from  $3^{rd}$ ,  $4^{th}$  &  $5^{th}$  years pursuing law under the Five-Year Degree Programme and students from  $2^{nd}$ &  $3^{rd}$  years pursuing law under the Three-Year Degree Programme are eligible to participate in the Debate Competition.

### **Topics for the Competition-**

- 1. Right to Die: Should Euthanasia be legalised?
- 2. AADHAAR Linkage: Better transparency or invasion of privacy?
- 3. Should Section 377 of the Indian Penal Code, 1986 be struck down for decriminalising homosexuality in India?

4. Should Death Penalty be abolished?

Participants have to prepare for all the topics in advance as any of the aforementioned topics can be put forth to the selected teams for the following rounds-

- The tournament shall comprise of three rounds namely, Preliminary Round, Semi-Final Round and Final Round. The Preliminary Round will be open to all the 8 teams.
   The topic will be given to them before the commencement of the round and their stance with respect to the motion will be decided on the spot through draw of lots.
- 2. Out of these 8 teams, 4 will qualify for the Semi-Final Round. The topic will be given to them before the commencement of the round and their stance with respect to the motion will be decided on the spot through draw of lots.
- 3. Out of these 4 teams, 2 will qualify for the Final Round. The topic will be given to them before the commencement of the round and their stance with respect to the motion will be decided on the spot through draw of lots.

## **Rules of Competition**

- 1. In the **Preliminary Round**, each team shall be given total time of 8 minutes to speak. Each participant from each team has to speak for at least 3 minutes out of the 8 minutes. Teams exceeding their allotted 8 minutes time will be penalised. No rebuttals will be allotted for this round.
- 2. In the **Semi-Final Round**, each team shall be given total time of 10 minutes to speak. Out of 10 minutes, 2 minutes are reserved for rebuttals. Each participant from each team has to speak for at least 3 minutes out of the 8 minutes. Teams exceeding their allotted 10 minutes time will be penalised. They will be provided with a preparation time of 10 minutes after the conclusion of the Preliminary Round.
- 3. In the **Final Round**, each team shall be given total time of 15 minutes to speak. Out of 15 minutes, 3 minutes are reserved for rebuttals. Each participant from each team has to speak for at least 5 minutes out of the 12 minutes. Teams exceeding their allotted 15 minutes time will be penalised. They will be provided with a preparation time of 10 minutes after the conclusion of the Semi-Final Round.

2<sup>nd</sup> Prize: Trophy and Cash Prize of Rupees Ten Thousand Only
