MOOT RULES

Rules and Regulations of 9 th RCL National Moot Court Competition, 2019.

1. DEFINITIONS:

These rules are to be called, the Rules for 9 th Rayat College of Law National Moot Court Competition, 2019. Whereas, Organizer means Rayat College of Law, Railmajra (Ropar Campus).

2. ELIGIBILITY FOR PARTICIPATION:

The Colleges/ Universities/ Institutes pursuing with LL.B (Five Year or Three Year Degree Course) in the current academic year are eligible to participate in this competition.

However, only one team per university/institution shall be eligible to participate.

3. TEAM COMPOSITION:

The participating College/University/Institute shall nominate one team consisting of three students for the competition.

Each team shall comprise of three students (two speakers and one researcher). An observer may accompany the team but no certificate shall be provided to him/her. In case of any contingency, the researcher may substitute the speaker only with the prior permission of the organizer.

4. DRESS CODE:

Participants are required to adhere to the following dress code while present in any court room during the competition:

LADIES: White shirt and black pant/black skirt along with black tie, black coat and black shoes.

GENTLEMEN: White shirt, black trousers, black tie along with black coat and black shoes.

Strict adherence to the dress code is solicited. Failure will result in disqualification.

5. REGISTRATION:

The last date for registration is **February 15, 2019**.

Participation for the competition is strictly by registration.

Communication for the same shall be sent on the separate Registration Form annexed herewith, completely filled and duly signed by the Head of the participating College/University/Institute along with a draft worth **Rs. 4200/-** as Registration Fee on or before **15 February, 2019** (soft copy) and on or before **20 February, 2019** (hard copies) drawn **in the favour of The Principal, Rayat College of Law, Payable at Ropar.**

6. SUBMISSION OF MEMORIAL:

- The participating teams must submit four hard copies of the memorials prepared from both the sides, i.e., “for” and “against” according to the proposition (4 copies from respective sides i.e. total of eight copies), on or before **20/03/2019** the participants must send soft copy of the above stated documents to **rclmootcourt2016@gmail.com** by **15/03/2019**.
- Each team will be given a code on submission of memorial.
- Copies and Documents submitted shall be the property of the organization.
- The participating teams will have to report on **30/03/2019** at Rayat College Of Law, Railmajra.

RULES FOR PARTICIPATION:

Guidelines for Formatting:

- Memorial or counter memorial shall not be more than 30 typed pages.(A4 Size), which consists of the format stated below.
- The participating teams are required to prepare written submission/Memorials from both the sides, total 8 copies of the memorials will be required to be submitted.
- Memorials and the oral submissions must be prepared and presented in English only.
- The body of the memorial must be double line-spaced, with one inch margin on both sides and in font size 12 (Times New Roman)
- The text of footnotes may be single line spaced. The font size of the footnotes must be 2 points less than the text font.
- Quotations of sources outside of the memorial of 50 words or more in any part of the memorial shall be block quoted and must be single spaced.
- The cover page of the memorial prepared “for” shall be in Blue.
- The cover page of memorial prepared “against” shall be in Red.
- Name of the college and participants should not be written on the memorial.
- Speakers shall not be allowed to pass annexure to the judges; instead the teams may make a set of compendium of annexure that shall be given to the judges before the commencement of proceedings.
- The table of contents, Index of Authorities and Case Title are not included in the 30 typed pages limit.

7. CONTENT OF MEMORIALS:

The Memorial shall consist of the following parts:

- Cover page
- Table of contents
- Index of authorities
- Statement of Jurisdiction
- Statement of issues/charge/law points
- Statement of facts
- Summary of pleadings
- Body of pleadings
- Prayer
- Exhibits/ Appendices (Optional)
- Verification

SCORING PATTERN: The assessment of the teams during the Moot Court Competition shall be out of maximum of 100 Marks set out as follows:

8. REGISTRATION

All the teams are required to report on **30/03/2019** at **9:00 A.M** and draw of lots will be observed for the preliminary round. There will be no exchange of memorials for the preliminary round.

ROUNDS:

There will be four rounds in total i.e.,

- PRELIMINARY ROUND OF ARGUMENTS
- QUARTER FINALS
- SEMI-FINALS
- THE FINALS

1. PRELIMINARY ROUND:

- Each team shall have two pre appointed speakers for each round.
- The same speakers shall represent the team in all the rounds.
- The team that will argue first will be decided through a draw of lots.
- Each team will get a total of 20 minutes to present their case and which shall include the time for 'rebuttal' and 'Sur-rebuttal'. Any extension of time beyond the specified period shall be subject to the discretion of the judges.
- The division of time between the speakers is the discretion of the team members, subject to a minimum of 5 minutes for one speaker.
- It is mandatory for both the speakers to present their case in a comprehensive manner.
- Memorials will not be exchanged for this round.
- The assessment will be based on the scoring pattern provided herein.
- This will be an elimination round. The decision of the sitting judges will be final
- Top eight teams will qualify for the quarterfinal rounds.
- In the case of a tie, combined total marks of the preliminary round shall be considered. The team with the higher score will advance to the quarter finals. If the situation still persists, then it would be resolved by considering the memorial scores.

2. QUARTER FINAL ROUND:

- Qualification to the quarter final round will be based on win points.
- The team that will argue first will be decided through a draw of lots.
- Each team will get a total of 20 minutes to present their case which shall include the time for 'rebuttal' and 'Sur-rebuttal'. Any extension of time beyond the specified period shall be subject to the discretion of the judges.
- The division of time between the speakers is the discretion of the team members, subject to a minimum of 5 minutes for one speaker.
- It is mandatory for both the speakers to present their case in a comprehensive manner.
- Memorials will be exchanged for this round.
- Top Four teams will qualify for the semi final rounds.

3. SEMI FINAL ROUND:

- The top four teams will qualify for the semi final round.
- The team to argue first shall be decided through a draw of lots.
- Each team will get a total of 25 minutes to present their case which shall include the time for 'rebuttal' and 'Sur-rebuttal'. Any extension of time beyond the specified period shall be subject to the discretion of the judges.
- The division of time between the speakers is the discretion of the team members, subject to a minimum of 10 minutes for one speaker.
- It is mandatory for both the speakers to present their case in a comprehensive manner.

- Memorials will be exchanged for this round.
- The decision of the judges as to the marks allotted to any team shall be final.
- The two winning teams from semi-final round will make it to the final.

4. FINAL ROUND:

- The team that will argue first shall be decided through a draw of lots.
- Each team shall get a total of 30 minutes to present their case. This time will include the time for 'rebuttal' and 'Sur-rebuttal'.
- The division of time between the speakers is the discretion of the team members, subject to a maximum of 15 minutes for one speaker.
- The memorials for this round will be exchanged as soon as the result of the semi-finals is declared.
- In case of any tie, the decision of the judges shall be final.

9. IMPORTANT GUIDELINES AND PENALTIES:

1. Participants are expected to observe a proper dress code and make their own arrangements for coats, ties.
2. Students shall not interact with the judges or reveal their identities or the identity of their respective college. Any such attempt shall result in instant disqualification. Colleges will identify themselves to the judges only by the codes given to them at the time of submission of Memorials.
3. The language of the court shall be English.
4. The court will follow its own rules of procedure within the framework of accepted norms of judicial practice. On questions of doubt or dispute in the matter of procedure of facts, the decision of the court shall be Final.
5. Every team must maintain complete dignity and decorum in the Courtroom. Inappropriate behaviour in the Courtroom or blatant disregard for the procedures will result in instant disqualification or defaulting team will be incurred the penalty of 5 points, as per the decision of the presenting judges.
6. Scouting in any manner is strictly prohibited.
7. No team member or person directly associated with any team is permitted to attend any round in which the said team is not participating during preliminary rounds.
8. Each participant must possess his/her I-card on the day of the competition.
9. Prior information for the hostel facility is solicited.

10. IMPLEMENTATION AND INTERPRETATION OF RULES:

- **Regarding competition practice and procedures, the final decision on the interpretation and implementation of rules lies with the organizers.**
- **The Organising Committee reserves the right to amend/change the rules & regulations with prior notice to all registered teams.**

11. MISCELLANEOUS:

- * Upon completion of the competition, the organising committee reserves the exclusive right to use the memorials submitted to them, as they deem appropriate.
- * The Organising Committee reserves the right, at its sole discretion, to take appropriate action for any unethical, unprofessional and wrongful conduct during the entire period of the competition.
- * Participating teams should carry with them required study or reference materials for their own use during the competition.
- * Participating teams shall be expected to maintain the proper decorum of the courtroom during the proceedings and shall conduct themselves in a manner befitting the legal profession.
- * The Organising Committee reserves the right to amend, modify or repeal any of the rules if so required and as they deem appropriate. Participating teams shall receive adequate notice of any/all such amendments or modifications to the rules.
- * The Organising Committee shall not be held responsible for any loss or non-delivery of the memorials.

12. CASH PRIZE:

1ST PRIZE: Rs. 5000/-

2nd PRIZE: Rs. 3500/-

BEST MEMORIAL: Rs. 2500/-

BEST MOOTER: Rs. 2500/-

13. AWARDS:

Following awards shall be distributed during the award ceremony:

1. The winner of the final round will be declared the “**WINNER**”.
2. The runner-up of the final round will be declared as the “ First Runner Up”
3. The “**Best Mooter**” award shall be given according to the points scored by Mooter in all the rounds.
4. The “**Best Memorial**” award shall be declared on the evaluation of the memorials submitted by participating teams.
5. In addition to the above awards, certificates shall be issued to all the participants.

DATE & VENUE:

RCL National Moot Court Competition shall be held on 30th and 31st March, 2019 at 9:00 A.M at Rayat College of Law, Railmajra, Ropar, Punjab (140001)

9 th RCL NATIONAL MOOT COURT COMPETITION**Moot Court Problem**

1. Saleem (complainant), a vegetable vendor, living with his family consisting of his wife and three children in Village Railmajra District S.B.S. Nagar. Saleem's sister Fatima was residing with her husband Bashir Khan and daughter Sameena (deceased) in Uttar Pradesh.
2. Fatima died in 2004 and her husband Bashir Khan left the custody of her daughter Sameena aged about 2 years with Complainant. The Complainant was looking after Sameena along with his own children. Sameena used to go to learn stitching for the last 3-4 months before the occurrence at about 10-00/11-00 a.m., along with other female children of the area of the residence of the complainant.
3. On 23-9-2015, Noori daughter of Naushad took away Sameena from House. Then Sameena returned after a short interval. Again at about 5.15 pm, Noori took Sameena with her on the pretext of defecating where after Sameena did not return. Despite search she could not be found. On 29.9.2015 at about 6 pm dead body of Sameena was found in the bushes near cremation ground of the village by Noor Jahan wife of the complainant, who was informed by a 12 year old boy Dilbar from the neighbourhood. On receipt of information from his wife, the complainant along with his brother Rehman and other neighbours went to the said place. Dead body of Sameena was lying there. There were injury marks around her neck. Jute thread was also there around her neck. One of her foot was found tied with dupatta. She was naked from lower part. Her garment was lying at a distance. Blood was also scattered there. Slippers of the deceased were also found at some distance. One Black colour Male Slipper was also found there. From Circumstances observed by the complainant it seemed that Sameena was killed and then her dead body was dragged into bushes. After recording the statement of Saleem, FIR was registered under Section 302 IPC. Inquest report about the condition of the dead body of Sameena was prepared. Dead body was dispatched to Civil Hospital, S.B.S. Nagar for post-mortem examination. Post-mortem report revealed that death resulted due to neck injury and possibility of rape cannot be ruled out before death.

4. On 26.9.2015, Sadiq Hussain made statement to the police that, on the day of occurrence he over heard one Abdul Khan talking with his companion, while sitting at dhaba, that he had tried to commit rape on the person of one female child but when she started crying, he killed her.

5. On 28.9.2015, Abdul Khan made extra judicial confession before Sukhwinder Singh Namberdar that on 23.9.2015 Sameena Niece of Saleem was found going into the jungle to defecate and on seeing her, he became furious in sexual lust and dragged her into the bushes. When tried to commit rape on her person by putting off her cloth, she resisted and raised cries, due to which he took out jute thread from his pocket and tied it around her neck and strangled her to death. Thereafter, he dragged her dead body into the bushes and after leaving it there he ran away. As the police was behind him and therefore, he should help him for his production before the police so as to avoid his torture at the hands of the Police. Sukhwinder Singh Namberdar produced the accused before SHO. Accused Abdul Khan was nominated in the case and was formally arrested.

6. On 28.9.2015, accused suffered disclosure statement in the presence of Kareem neighbour of the complainant in which he stated that he had kept concealed blood stained knife into the bushes near the place of occurrence and could get the same recovered. On such disclosure blood stained knife was recovered and was taken into possession after putting it into a sealed parcel.

7. On 30.9.2015, accused again suffered disclosure statement in presence of Shabir and Ahmed (both resident of village Railmajra) that he had concealed his blood stained clothes and jute thread in the bushes near old Mosque from where he got recovered his blood stained khaki colour jean pant, green colour shirt having blue strips and jute thread which were taken into possession after putting them into separate sealed parcels.

8. 27-9-2015, Dilber made a statement that on 25-9-2015 at about 4.30 pm he was returning to his house from market. Present accused Abdul Khan is also resident of his area. He met the accused on the way near cremation ground. He heard some noise from the bushes near cremation ground and rushed to the bushes and saw sameena lying in the pool of blood. He got frightened and informed about this incident to Noor Jahan, aunt of Sameena

9. After Commitment of the case to the Court of Session, Charge under Sections 302, 376-A IPC read with Section 4 and 18 of the Protection of Children from Sexual Offences Act, 2012 was framed against the accused to which he pleaded not guilty and claimed trial.

10. During trial prosecution produce PW Saleem, PW1 Sadiq Hussain, PW2 Sukhwinder Singh, PW3 Kareem, PW4 Shabir, PW5, Ahmed, PW6 Dilber. All corroborated their statement given before police. After closure of the prosecution evidence, statement of accused under section 313 Cr.P.C. was recorded putting the entire incriminating evidence to him, which has emerged on record from the side of the prosecution. The accused has alleged false implication. Version unfolded by the accused was that he has been falsely involved in this case as it was unsolved death case of a child, Father-in-law of PW Sadiq Hussain and the father of the accused are real brothers. They have property dispute at their native place and due to this all private witnesses have made a plan to involve him in this case. The accused has not led any evidence in defence.

11. After hearing public prosecutor, learned defence counsel and have also gone through the prosecution evidence on record, the trial court observed that all the links to connect the accused with the crime are missing. The circumstantial evidence projected against the accused is not of a stature to rule out any other hypothesis except that the crime was committed by him. The circumstantial evidence of the prosecution is not consistent with the guilt of the accused. Therefore, the court held that the prosecution has failed to prove the guilt of the accused beyond reasonable doubt and by giving the benefit of doubt the accused was acquitted of the charge framed against him.

12. Aggrieved by the Judgement of acquittal passed by the learned trial judge, the prosecution have preferred the present appeal. Argue on behalf or against the parties.

Statement of Issues:

1. Whether the respondent/accused can be convicted under section 302 of IPC?
2. Whether the respondent/accused can be convicted under section 376-A IPC read with Sections 4 and 18 of Protection of Children from Sexual Offences Act, 2012?

3. Whether the circumstantial evidence projected against the accused form a chain of evidence sufficient to prove the guilt of the accused?
4. Whether the trial court was justified to set free the accused from all the charges levelled against him by the prosecution?

NATIONAL CLIENT COUNSELLING

Competition Dates: 30th & 31st March 2019. Reporting time will be **9:00 A.M** on **30th March 2019.**

1. IMPORTANT NOTE:

Students participating in Moot Court Competition are not allowed to participate in Client Counselling and vice versa.

2. TEAM COMPOSITION

- 1) Each team must consist of two participants only.
- 2) The two participants may be from any of the LL.B. 3 year course or B.A. LL.B/B.COM.LL.B 5 year courses. Teams shall not be altered after registration.

3. COMPETITION FORMAT

- 1) There shall be 3 Rounds of Counselling session. The Preliminary Counselling Session, then the semi-finals (1 team with highest mark from each rooms) and two teams with highest score from the semifinals will be selected for the Final Counselling Session. Rules given below shall apply to both rounds.
- 2) Total time given will be **30 minutes** per team (for preliminary round and semifinals) and for the finals time allowed will be **40 minutes**.
- 3) Each Counselling Session is divided into three parts: Consultation, Post-Consultation and Critique

CONSULTATION:

- 1) The consultation period shall be for **20 minutes**.
- 2) The time period will start from the moment the client enters the chamber.
- 3) The time period is meant to be used for inter alia consultation with the client during which participants are expected to elicit the relevant information, outline the problem, find the clients expectations and propose a solution or other means of resolving the problem.
- 4) During the consultation and post-consultation, the team may use books, notes and other materials. The team may also use office props (Files, furnishings, bookshelves etc.) and any other material to furnish their consultation room or for other relevant purposes which is to be brought by the teams themselves.

5) The time period is to be strictly adhered to but the judges may, in case of any reasonable circumstances provide an extra one minute to the team after which the client would necessarily leave and the post-consultation period would begin.

6) If the extended consultation session allowed an opportunity for a team to gather more information than other teams, this circumstance should be taken into consideration by the judges in making their decision. Judges may, in their discretion, penalize teams that allow the interview session to run longer than the stipulated time period.

POST CONSULTATION:

1) In the post-consultation period the participants shall talk to each other loudly so as to be audible to the judges or may indirectly address them in any other manner.

2) Participants may summarize the interview, indicate the scope of the legal work to be undertaken, and state the legal issues that should be researched.

Explanation of the position or attitude taken by the students may be useful.

3) If the students feel that some documents are appropriate, like a letter to the client confirming their retention as attorneys, the fee arrangement etc, or a letter to 2 opposing counsel or to the party with whom the client is having their legal problems etc., they may dictate such a document at the post consultation stage.

4) The time period for post consultation is **5 minutes**.

5) At the completion of the time period of Post-Consultation the time Keeper shall stop the participants or signal them to stop in an obvious manner. Failure of the participants to comply with the above rule will attract negative marking as prescribed by the Organizer to the judges.

CRITIQUE:

1) After the completion of the Post-Consultation period the judges may question the participants on matters deliberated upon or mentioned by the participants or the client during the consultation of post-consultation period.

2) The judges may ask any question which they consider material and questions meant to test the participants understanding of the facts and/or law applicable or applied by the participants in the case.

3) The time period for this session is **5 minutes** and the judges may extend it at their discretion.

4. SEMIFINALS: The time and rules for semifinals shall be same as the preliminary round. 1 team with highest mark from each room will be selected for finals

5. FINALS:

Same rules as prelims to be applied but the total time allowed will be 40 minutes divided as follows:

- 1) Consultation: 25 minutes**
- 2) Post consultation: 7.5 minutes**
- 3) Critique: 7.5 minutes**

6. LAW APPLICABLE:

The problems shall be broadly based on but not completely limited to the following laws and participants are expected to have knowledge of any other ancillary laws and procedures:

- (i) Constitution law
- (ii) Family law
- (iii) Indian Penal Code,1860,Code of Criminal Procedure,1973
and Indian Evidence Act,1872

7. JUDGING CRITERIA (total 100 marks)

1. Alternative Courses of Action (10 marks): Consistent with the analysis of the client's problem, developed a set of potentially effective and feasible alternatives, both legal and nonlegal.

2. Client's Goals and Expectations (20 marks): Learned the client's goals and initial expectations; modified or developed these as necessary.

3. Moral and Ethical Issues (10 marks): Recognized, clarified and responded to any moral or ethical issues which may have arisen, without being prejudicial in judgments.

4. Post-Interview Reflection(20 marks): During the follow up phase, gave evidence of having recognized their own and the client's feelings, the strengths and limitations of their interviewing and counselling skills, their handling of the substantive aspects of the client's problems (legal and non-legal), provided for an effective follow-up.

5. Problem Analysis and Effective Conclusion (20 marks): Analysed the client's problem with creativity and from both legal and non-legal perspectives, resulting in a clear and useful formulation of the problem.

6. Teamwork (20 marks): As collaborating counselors, worked together as a team, with flexibility and an appropriate balance of participation. Marks allotted by the Judges shall be final.

8. AWARDS:

There shall be a winner of the Competition and other awards and prizes may be declared during the prize distribution of the Competition. Cash prize will be as follows:

- 1) 1st Prize: Rs. 3500/- WINNER
- 2) 2nd Prize: Rs. 2500/- First Runner up
