Identity is equivalent to dignity. In National Legal Services Authority v. Union of India and Others J.Radakrishnan, after referring to catena of judgments of certain International Covenants, opined that gender identity is one of the most fundamental aspects of life which refers to a person's intrinsic sense of being male, female, or transgender or transsexual person. Judgments, albeit represent the nation, cannot change the thoughts of the society.

The preposterous and dastardly contemplation of India will only be razed when the youth of this country, which represents more than half of the Indian population changes its thoughts.
