ABOUT THE PROGRAMME

India is a social, democratic, republic governed by rule of law. The Constitution of India guarantees all citizen basic fundamental rights including equal treatment and protection of law. If law is equal for all, accordingly access to justice should be similarly available to all. Despite these robust constitutional protections, large sections of society particularly the marginalized groups face onerous burden to access legal protection. Today there is an access-to-justice "crisis" imperiling the country's legal system as access to courts is expensive, time-consuming, procedure-ridden, technical and difficult to comprehend which impedes poor and vulnerable people from approaching the same.

In the light of the above mentioned, this conference has the objective to delve, deliberate and to generate awareness amongst students of varied disciplines and the legal luminaries through criminal and correctional legal mechanisms, its impact and implications on the marginalized community and to discuss measures possible to resolve.

RULES FOR SUBMISSION:

- The registered and selected participants only shall be allowed to present their paper in the conference subject to submission of complete papers in due course of time. Papers received after stipulated deadline shall not be entertained for participation in conference.
- The papers should be developed and written in a symmetrical way responding to a theme of conference. It should have proper research questions and should also reflect the findings. The paper should not be more than 5000 words. The abstract should not be more than 250 words. The paper must be typed in Times New Roman, Font Size 12 on A4 size paper on MS word. The personal details of author must be given in paper. Harvard Blue Book must be referred for proper citation and acknowledgment.
- On the spot registration shall be done on the day of conference. Selected and submitted abstracts shall be published in the souvenir of the conference.
- The submissions should be original and unpublished.
- Co-authorship is allowed but it is mandatory that at least one author shall be present for paper presentation. However, each co-author has to mandatorily register themselves separately on payment of mentioned registration fee.
- Language no bar.
- Presenters will be allowed to present their papers through Skype in case they are unable to present physically.
- In the aftermath of the conference, the selected full papers after scrutiny by the Editorial Board would be considered for publication in the UGC Approved Journal or Edited Book.
- The abstract should not exceed 200-250 words, and must be accompanied by a cover page, stating the Sub-Theme, Title of the Paper, Keywords (5-8 words), Name of the Author(s), Name of the Institute, E-mail Address, Postal Address, Contact number.
