- The length of the paper shall not exceed 4500 words, excluding footnotes and the abstract.
- The submission shall be in MS-Word format (.doc or .docx) and must be typed in A4 paper with one inch margin on all the sides.
- Font size shall be Times New Roman 12, with 1.5 spacing. Font size for the footnotes shall be Times New Roman 10, with 1 spacing.
- Bluebook 20th Edition citation shall be followed.
