5th National Alternative Dispute Resolution Competition, 2020

The 5th National Alternative Dispute Resolution Competition, 2020 is the fifth edition of the flagship event of ADR Board, SLCU. The 5th NADR aims to create a platform for likeminded individuals with an interest in ADR to indulge in an intellectual and thought provoking competitive simulation of Negotiation, Mediation and Client Counseling. The competitions will be held from the 16 January, 2020 to the 18 January, 2020. The brochure holds detailed information regarding the competition.

Client Counseling

One of the significant roles of a lawyer is to enlighten the clients who look to seek assistance in understanding the legal implications of their actions. The lawyer is looked upon to facilitate decision making in certain critical legal matters. This function of the lawyer influencing and facilitating decisions is called counseling. Client counseling is a session where a prospective client approaches an advocate to seek legal counseling relating to a legal dispute. The 5th NADR recreates this by providing opportunity for students to tackle the various legal issues brought to them, using their legal skills.

Mediation

Mediation is a voluntary dispute resolution method in which the parties discuss their disputes with the assistance of a trained and impartial third person who facilitates them in reaching a settlement. The neutral third party mentioned herein is the mediator. Mediators will be selected from two separate teams to preside over the dispute of Client-Advocates from the other two teams.

- * Registration fee: Rs.4,500/-
- * Members per team:
 - 3-1 Mediator
 - 1 Client
 - 1 Advocate
- * Time Limit: 30 minutes

Negotiation

- * Registration Fee: Rs.3,000/-
- * Members per team: 2
- * Time limit: 30 minutes

Negotiation is the first step in dispute resolution. The parties in this method put forth their respective interests and engage in discussions to resolve their dispute amicably. Usually, lawyers play a relatively passive role in Negotiation. The 5th NADR will stimulate this experience based on a pre-determined problem on which the parties will engage in negotiation.

1. <u>University Provisional Application</u>:

The provisional application is available on our Official Blog, Social Media Accounts-Facebook and Instagram, Lawctopus and will be sent via mail for universities requesting the same.

2. Team Application Submission:

The application forms for the teams will be sent via email to individual universities that have registered and got shortlisted through Provisional Registration. The teams shall then register for the event through the registration form sent via email.

3. Registration fee and Accommodation charges:

The details regarding registration fee and accommodation charges will be communicated to the teams who have complied with the rules regarding the previous steps. Please note that the registration fee and accommodation charges are separate and not inclusive.
