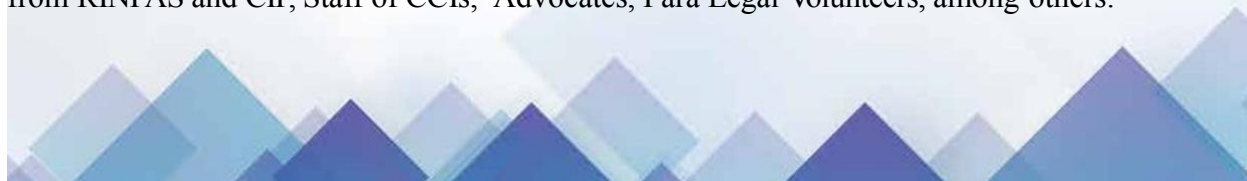
Objectives

- To improve the understanding about the institutionalized framework of the Juvenile Justice system.
- To develop the understanding about the standards of care and protection of children in conflict with law & children in need of care and protection.
- To provide an understanding about the legal framework relating to adoption.
- To familiarize the participants with the Juvenile Justice (Care & Protection of Children) Model Rules, 2016 and Jharkhand Juvenile Justice (Care & Protection of Children) Rules, 2017.
- To familiarize the participants with the Jharkhand Guidelines for Sponsorship of Children, 2018.
- To provide practical understanding about the juvenile justice system at the grass roots level through field work.

Pedagogy – Classroom Lectures, Presentations, Case-study Method, Interactive Sessions, and Field Work.

Police Officers; Members of JJB, CWC, SJPU, DCPU, and ICPS; Staff of Child Line, Counselors from RINPAS and CIP, Staff of CCIs, Advocates, Para Legal Volunteers, among others.

Module – 2: International instruments related to Child & Law and Principles of Care & Protection of Children (01 Hour)

Module – 3: Institutional framework and administration of juvenile justice relating to Children in conflict with law & Child in need and protection (03 Hours)

Module – 4: Rehabilitation, Social Reintegration & Standards of care and protection (03 Hours)

Module – 5: Institutional & Non-institutional Framework related to Adoption (02 Hours)

Module – 6: Miscellaneous aspects related to child (01 Hour)

Module – 7: Orientation for the field work (01 Hour)

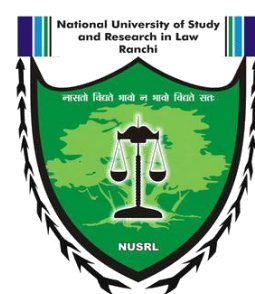
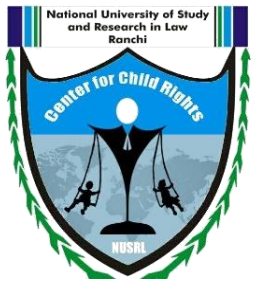

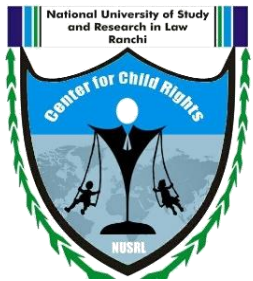
