----- IMPORTANT GUIDELINES -----

Participation Guidelines

- Co-authorship is allowed up to three authors.
- It is mandatory that at least one of the authors be present for paper presentation.
- All the abstracts & papers will be subject to blind peer review.
- Paper presenters will be given 'Certificate of Presentation'.

Submission Guidelines

- All the pages of the Final Paper should have a margin of 1 inch on all sides;
- Main Title of the Paper: Font – Times New Roman; Size – 18; Line Spacing – 1.5; Alignment – Centre; Uppercase; Boldface;
- Body: Font – Times New Roman; Size – 12; Line Spacing – 1.5; Alignment – Justified; the citations must be typewritten in the font: Times New Roman, Font Size: 10, Line
- Spacing: 1.0 and justified alignment. Submissions must conform to a uniform method of citation.
- Authors are requested to stick to the word limit.
- All papers must be an original work of the author(s). Plagiarism will lead to cancellation of the paper.

Structure of Submission & Word Limit

Papers may be submitted under the following categories:

- **Long Articles:** Between 5000 and 8000 words. Papers in this category are expected to engage with the theme and literature comprehensively,
- **Essays:** Between 3000 and 5000 words. Essays are expected to be far more concise in scope.
- **Case Notes and Legislative Comments:** Between 1500 and 2500 words. These are analyses of any contemporary judicial pronouncement or a new piece of legislation whether in India or elsewhere.

Publication Opportunity

Papers *guaranteeing merit & qualifying peer review shall be published* in a Internationally Indexed Journal with ISSN.
