As per to abide by the guidelines and to maintain the quality, sanctity, uniformity and smooth sailing of The Article Writing Competition '**Scrībere**' there are number of guidelines the participant(s) need(s) to follow before submitting their Article.

The **guidelines** are as follows:

- The Competition is open for all the students currently pursuing their under-graduation/ post graduation course from any recognized university/college in India.
- All the participants willing to participate in the Article Writing Competition need to submit their Article at Google Form linked below:

- The article needs to be submitted it in Microsoft Office doc/ doc.x format.
- The participant/participants need/needs to complete the whole Article in 1000 1500 words.
- Co-authorship of a maximum of **2 persons** is permitted.
- There will be a restriction of one article per author/ one article per co-authors. Multiple submissions from the same author will not be entertained.
- No citation is allowed, only references are permitted as it is an opinion based Article Writing Competition.
- The participant/participants while submitting their Article needs to send their **biography** / cover letter in 80 words [maximum] which will cover their profession/educational institution, their current year and age.
- Last date for submission is May 15, 2020.

Themes

Authors (s) are free to write on any one of the social / political / legal topics given below:

- 1.UAPA against Freedom of Speech and Expression?
- 2. Covid 19: A turning point in World Politics
- 3. Covid 19:Rise in Communalism and Racism in India
- 4. Is Indian Nationalism Being Redefined?
- 5. Covid 19 and the fight against Climate Change
- 6. Prism Journalism in India: Way Forward?
- 1. The articles will be scored based on originality of analysis, depth of research, style of writing and communication of arguments. The decision of the evaluators will be final and binding.
- 2. The organizers reserve the right to publish and disseminate article submitted to and for the Competition. Submission of the article in this Competition shall constitute consent to such publication and dissemination.
- 3. A certificate of participation shall be e-mailed to all participants who have successfully submitted the article.
- 4. The organizers are very particular about the plagiarism as it defeats the purpose of the Competition. Only original articles that have not been published elsewhere and have not been submitted to any other organization are to be submitted. Hence, the participants are advised to take care of the same.
