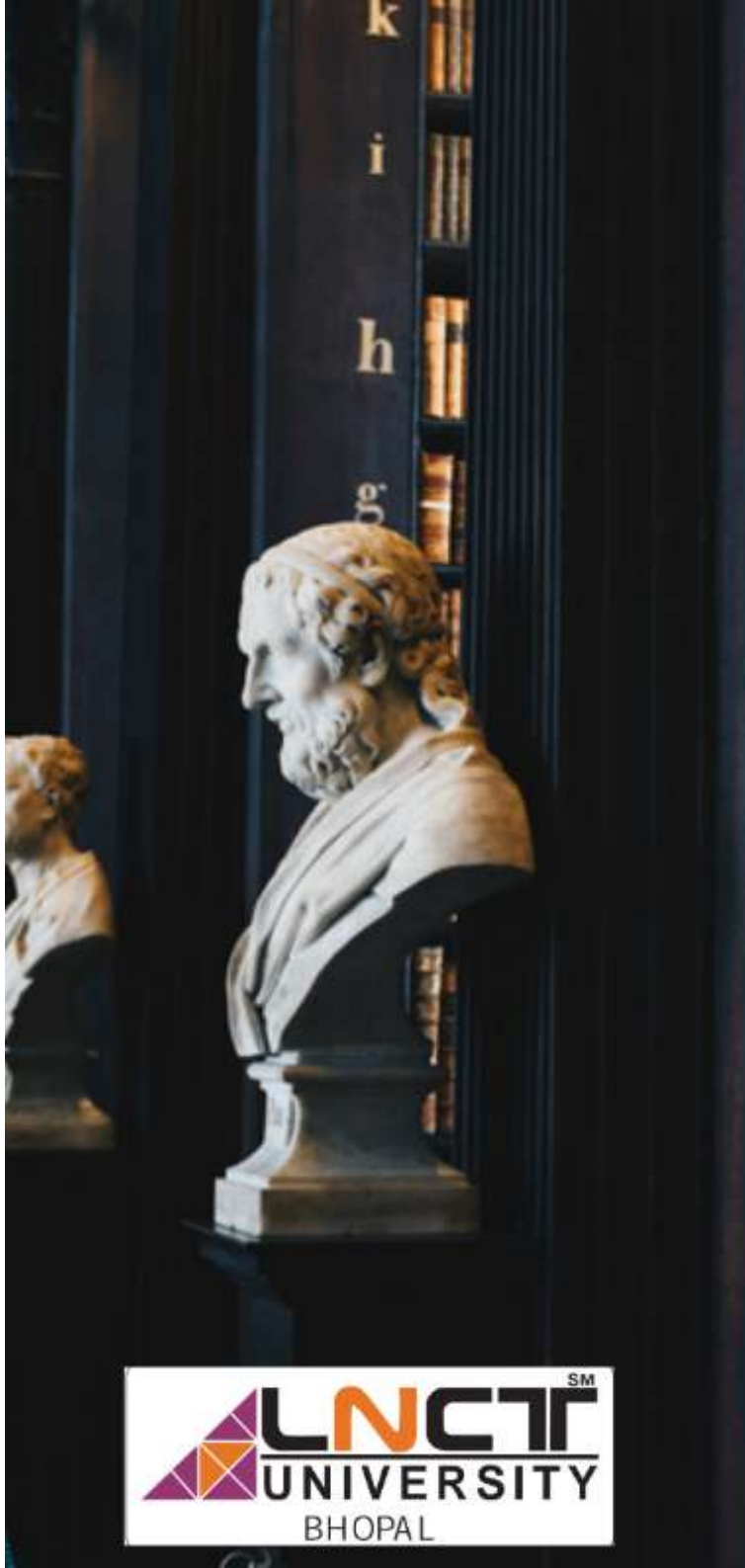

ELIGIBILITY

- Undergraduate students pursuing five-year or three-year courses of B.A.LL.B./B.B.A.LL.B./Integrated degree(s) of law or any postgraduate student (pursuing LL.M) from any Law School/College/University recognized by the Bar Council of India.

TEAM COMPOSITION

- One team comprising of a maximum of three (3) members shall be eligible to participate in the competition. Given that they have completed all the registration formalities.
- In a team of 3 members, 2 members should be the speakers, to present the case and one member should be the researcher.
- In a team of 2 members, 2 members should be the speakers, to present the case and out of those two members one must also represent as a researcher.
- Each team has to prepare, two memorials. One from the side of the Petitioner/Appellant and the other from the side of the Respondent as the case maybe.

REWARDS

- Winning team - Rs. 15,000/-
- Runner-up Team - Rs. 5,000/-
- Best Mooter - Rs. 5,000/-
- Best Memorial - Rs. 5,000/-
