

"Army Law College Pune National Elocution Competition 2020" (Online) to be held on 18th December 2020 – International Migrants Day

<u>Rules</u>

- <u>Topic for the Competition</u>: "Human Rights of Migrants & Refugees: Global Issues & Challenges"
- The competition will be conducted online through Cisco Webex Meeting platform. The participation link shall be shared with the participants on 17th December, 2020
- 3. Participants will be seated with their webcams switched on. They should be dressed in formal attire. It shall be the responsibility of the participants to make sure that uninterrupted power supply and internet connectivity is available at their end throughout the competition.
- 4. The maximum time limit for speech shall be 10 Minutes. Exceeding time limit shall lead to deduction of marks. A one-minute warning will be given.
- 5. The speaker is expected to memorize his/her speech, and is not allowed to read any part of the speech from papers/laptop/mobile/ notes etc. Reading verbatim from notes/papers is not permitted.
- 6. There may be minimum 2 and maximum 3 judges for judging the competition. The judges may include academicians & lawyers.

7. MARKING CRITERIA:

- Contents and Analytical Ability 40 Marks
- Oratory skills 30 Marks
- Clarity and Originality of Thoughts 20 Marks
- Confidence, Demeanor and Presentation Skill 10 Marks



- 8. The judges will mark the candidates unanimously on a single marking sheet, in order to promote clarity in selection of meritorious and deserving candidates.
- 9. The decision of the judges shall be final and binding
- 10. Perchance, any situation arises, not contemplated in the rules, the organizer's decision on the same shall be final.

Only the students pursuing 5-Year Integrated B. A. LL. B or B.B. A. LL. B or B. Com. LL. B Programme from any recognized Law College/Law School/Law University in India shall be eligible to participate in the Competition.Each Law College/Law School/Law University can **nominate only one student for participating in the competition**.

Registrations will open on 1st December 2020 (11:00am onwards) and will close on 8th December 2020 (5:00pm). Only the first 30 students registering via email, in prescribed format, on or after 1st December 2020 (11:00am onwards) but before 8th December 2020 (5:00 pm) at <u>academics.alcpune@gmail.com</u> will be considered. The participants shall be required to attach a signed & scanned copy of the ALC registration form, Photo ID card (college ID or Addhar card/ Driving License) and nomination letter signed by the Principal/Dean/Director/Vice-Chancellor. (The soft copy of the registration form is attached herewith).

The participation of first 25 students applied shall be confirmed. Remaining 5 students will be waitlisted. After 30 students register for the competition, the registrations shall be closed & the intimation to that effect shall be published on our website www.alcpune.com

No mail for registration sent before 1st December 2020 (11:00am) shall be considered. The list of first 25 students along with 5 waitlisted students successfully registering for the competition, will be published on 9th December 2020 on our website. Only confirmed 25 students shall pay the registration fees. If any student withdraws, then the vacant slot will be made available to waitlisted student in the order of merit. Such student will be individually asked to pay the registration fees.

Registration Fees (Non-refundable): Only 500/- Rupees (per student participant) <u>payable after</u> <u>the registration is confirmed on 9th December 2020</u>. An RTGS of 500/- in favour of "Army Law College, Pune" should be done on or before 15th December 2020. Account details and timings will be intimated to the confirmed students via email.
