About The Seminar

Within the concept of constitutionalism is the idea of limited, open, transparent and accountable government which must truly represent the will of the people and not smoke-screen the will of the people. Constitutionalism is there to tame wayward governments that see no limits to their powers or simply ignore such limits in the guise of pursuing a common or greater good.

A good constitution does not of itself guarantee constitutionalism. Neither does constitutionality guarantee constitutionalism. Constitutionalism goes beyond a good constitution and beyond constitutionality of governmental action or country's laws. It is only through entrenched constitutionalism that a country's constitution may truly serve as the supreme law, reflecting and regulating government in the interest of the people. It is recognized that an important bulwark of constitutionalism is the existence of an efficient and effective mechanism controlling and compelling compliance with the letter and spirit of the constitution. There can be no constitutionalism if there is no secure judicial review mechanism that can independently enforce the provisions of the constitution, while checking and controlling any abuses of its provisions. Supreme Court of India has led the way in its role of entrenching constitutionalism and it remains a shining example on the central role the judiciary can play in entrenching constitutionalism in the country. The courts act as active guardians of the constitution.

Admittedly in constitutionalism, courts go beyond enquiring into the constitutionality of laws. Courts play a vital role in ensuring that the constitution continues to have social relevance, often breathing life into the text of the constitution and render it relevant to cotemporary circumstances. Upholding the rule of law, as the courts do, is not just for the popular and dominant majority. A constitution would serve no useful purpose if it failed to protect the weakest, poorest and most vulnerable including the minority.

Guidelines for seminar paper

- Abstract should be a maximum of 250 words indicating the theme of proposed research with five relevant keywords. The research paper should be strictly thematic.
- Full Paper must consist of minimum 2500 words and maximum 6000 words excluding references and footnotes (Descriptive footnotes and substantive text in the footnotes is not permitted).
- Footnotes must follow The Bluebook: A Uniform System of Citation (Harvard, 19th Edition).
- Abstract and Full paper is to be submitted in soft copy in MS-Word format (Times New Roman, font size 14 for the heading, 12 for the text and 10 for the footnotes with 1.5 spacing for the text and 1.0 spacing for the footnotes).
- A separate MS-Word File should be submitted containing the article title, followed by Author's Name, Co-author's Name (if any) affiliation, communication address, email and phone details.
- Submission of a declaration stating that the work is original and bonafide.
- Only one co-author is permitted.
