## **Submission Procedure:**

1. Essay/article shall not more than 5000 words (excluding footnotes and abstract)

- 2. The submission will consist of an abstract (not more than 150 words) and brief profile of the teams with details of the Department and College/University.
- 3. References (footnotes) must be strictly in accordance with the **Blue Book Style** (19<sup>th</sup> Edition).
- 4. Scanned copy of the Registration form along with Essay/paper must be mailed to the specified mail ID, on or before the stipulated deadline.
- 5. The Registration form must be signed by the head of the Department/College/University.

#### **Screening and Selection of Teams:**

There will be a preliminary screening of participating teams through Essay/Article Write-Ups on the specified theme as mentioned above. Thereafter 05 best teams will be finalised to participate in the Inter-College Debate Competition on 5th November 2016 at National Law University, Sector 14 Dwarka, New Delhi.

## **Judges for the Competition:**

Winners will be decided by a panel of 4 Members comprising of 3 eminent public figures and one member from ONGC.
