Abstract Submission:

Abstracts containing not more than 250 words (identifying your chosen Theme/Sub-Theme) may be submitted to knowledgesteezconference@gmail.com along with name and educational background, institution and contact details. All abstracts should be submitted through e-mail only. The Author(s) should indicate the theme on which the paper is based. Co-authorship is allowed (maximum 2 Authors and only in one paper), subject to registration of all.

Main Paper:

1. The length of the paper shall not exceed 4500 words, excluding footnotes and the abstract.
2. The submission shall be in MS-Word format (.doc or .docx) and must be typed in A4 paper with one inch margin on all the sides.
3. Font size shall be Times New Roman 12, with 1.5 spacing. Font size for the footnotes shall be Times New Roman 10, with 1 spacing.
4. Bluebook 20th Edition citation shall be followed.
