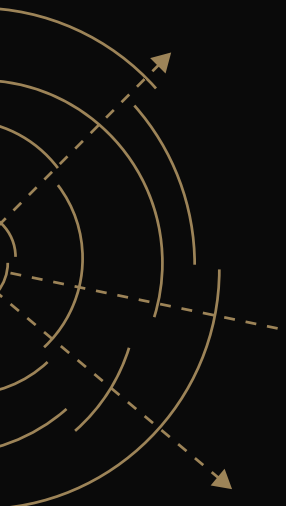
The Competition is open to undergraduate students, pursuing their courses in various colleges/departments/universities. Registration has to be made by a team of two members.
