## About The National Law Institute University, Bhopal

#### **Concept Note**



Consumer protection is the practice of safeguarding buyers of goods and services against unfair practices in the marketplace. It involves rights, duties and remedies available to consumers. Consumer protection laws play a crucial role in safeguarding the rights and interests of consumers, this becomes even more relevant with the advancement of digital economy in this globalised world. However, with the rapidly evolving marketplace and the emergence of new technologies and business models, it has become essential to acknowledge and revisit to strengthen the existing consumer protection laws. The conference aims to provide a platform for legal experts, policymakers, and stakeholders to discuss the challenges and opportunities in strengthening consumer protection laws regime.

In India, The Consumer Protection Act, 2019 is the country's main consumer protection statute replacing the previous Consumer Protection Act, 1986. The new Act enhances consumer rights protection, including the right to information, the ability to make informed decisions, the right to safety, the right to be heard, and the right to seek remedy. In addition, the Consumer Protection Rules, 2020 were framed under the Consumer Protection Act, 2019 to provide for the procedures

and guidelines to be followed by the Central Consumer Protection Authority and other bodies established under the Act.

The absence of protection agencies under the previous Act, which would have allowed for efficient and prompt control, regulation, and redress of consumer complaints, was one of its main shortcomings. The Central Consumer Protection Authority (CCPA) has been added to Chapter III of the 2019 Act in order to regulate issues relating to consumer rights violations, unfair trade practices, and false or misleading advertisements that are harmful to the interests of the public and consumers, as well as to promote, protect, and uphold the rights of consumers as a group.

In order to resolve consumer disputes, considerably more quickly, the Act has added a new chapter (Chapter V) on mediation as an alternative dispute resolution tool, to ensure speedy redressal of grievances. After three years of the Consumer Protection Act of 2019 being fully operational, including two years during the Covid Pandemic, it is important to talk about the difficulties in promoting consumer welfare and protecting their rights as envisioned under the Act and finding workable solutions to address those difficulties, including the efficient and significant operation of various bodies in digital mode.
