- Citation- endnotes (font size 10) in Bluebook 20th edition style
- After a Seminar, Unpublished original papers of interested authors will be published in a law journal "Vidhibharati"-ISSN-2321-6271 with separate fee Rs. 500 for processing and journal postal charges

Rules for Paper Presentation:
