We are pleased to announce the "Two-day Virtual National Conference on Law and Social Justice: Contemporary Issues and Challenges" organised by the Post Graduate Department of Law, Gauhati University, Guwahati and Droit Penale Group, A Unit of Arjun Das Gulati Memorial Society, Prayagraj on 26th August (Saturday) & 27th August, 2023 (Sunday).

FORMAT AND THEME OF THE CONFERENCE

- Miscellaneous (any topic relevant to the broad theme, other than the abovementioned subject areas)









The above list of themes is indicative and not exhaustive. The author(s) are free to choose any topic that falls within the domain of the main theme.

WHO CAN ATTEND?

Participation and/or paper presentation in the conference is open to academicians, researchers, students, practitioners and professionals from the legal domain, as well as other interested learners and students.

SUBMISSION GUIDELINES

- The abstract and full paper shall each contain a cover page with the following information:
- Title of paper
- Name of author(s)
- Designation and Institutional affiliation
- Email ID
- Phone number
- Apart from the cover letter, there should not be mention of details of the author(s) in any other part of the paper of the submitted file. The file name must contain the name of the author(s) along with the title of the paper in the format: "Name of the author(s)"_ "title of the research paper"
- The length of the abstract should not exceed 250 words and the full paper should be within 5,000 words (excluding the cover page).
- The abstract shall include 4-6 keywords.
- The abstract and the full paper should be typed in Times New Roman, font size 12 with 1.5 line spacing, and 1 inch (2.54 cm) margin on all four sides.
- The references should be typed in Times New Roman, font size 10 with single spacing.
- For citation and references, the ILI style of citation shall be followed.
- All submissions should be sent in .doc/.docx format only. Submissions in .pdf format will not be accepted.
- Co-authorship of up to two authors is permitted. However, each co-author has to individually register himself/herself for the Conference.
- The organising committee is not responsible for any copyright infringements by the authors.
- The copyright for all entries shall vest with the organizers, who herewith, reserve the right to modify the contributions as per requirement.

REGISTRATION FEE

- The soft copy of the final research paper must be submitted in .doc/.docx format to *paper.ncnep2020@gmail.com* with the subject "Research Paper"
- A cover letter mentioning the title of the paper and relevant sub-theme,
- Name of the Author(s), Course, Year Of Study(if applicable),
- Name of the college/university(if applicable),
- Professional Position (if applicable), with Postal Address, Email address and Contact Number.

Apart from the cover letter, there should not be any mention of any of the details of the author/s. The file name must contain the name of the author(s) along with the title of the paper. ("Name of the author/authors"_" "Title of the research paper").

Gauhati University has been serving as the Think Tank for the development of the entire Assamese Society throughout the history of the university.


ABOUT PG DEPARTMENT OF LAW, GAUHATI UNIVERSITY




