THEME OF THE SEMINAR

"Rights, Duties and State Obligations, Post-Truth Revelations"

in a democratic jurisprudence, State is neither the reservoir, not the repository or provider of rights but mere guarantor, protector and enforcer of the same. The post-truth era has emerged because of several long -cycle trends that affect the world around and humanity as a whole. Truth has become so relative in the Post-truth Era that the line between truth and falsehood has become too thin and prone to be fading away. Nation States put forward propaganda by giving the impression to their respective populations that the enjoyment of basic rights by the society is at the disposal of the State and citizens are duty bound to the State and not vice versa. This baseless construction has largely left the populations at the receiving end of only State-friendly but not people-friendly policies often resulting in growing socio-political rifts. Larger public sensitivity shall be cultivated to resolve the issue of his bogus populism by bringing back the unmatched ideals of democracy, liberty and welfare state. The two Day International Interdisciplinary on "Rights, Duties and State Obligations, Post-truth Revelations" organized by the Department of Law, Central University of Kerala, hopes to deliberate on the concerns shared by humanity accross the globe with the Post-truth conflicts.

SUBMISSION GUIDELINES

An abstract not exceeding 350 words shall be submitted for consideration on or before June 20, 2023 to alumniawcuk@gmail.com .Co-authorship upto two persons are permitted

The abstract shall contain:

- Title of paper
- Brief idea of the paper
- Conclusion indicating author's perspective
- keywords of the paper

The abstract shall indicate the name, designation, institution details, e-mail address and telephone numbers of all the contributors. In case of Co-authorship, each author will have to register separately in the event of participation in the conference. Selected abstracts will be intimidated after blind peer review. Therefore, the full papers shall be sent on or before June 27, 2023 to alumniawcuk@gmail.com

GUIDELINES FOR SUBMISSION OF FULL PAPER

- Length of the paper shall be less than 4000 words (including foot notes)
- Format : MS Word, Font Type : Times New Roman, Font Size : 12 Points, Line Spacing : 1.5
- For title of the paper 14 points capitals may be used
- Name and Designation of the author/author's shall be mentioned below the title of the paper
- Harvard Blue Book Style (19th edition) shall be used for citation.
- Full papers shall undergo blind peer review and plagiarism check. Plagiarized papers will be rejected.
- Revision (if any) suggestions by the reviewer of the paper shall be included. Revisions suggested are on the basis of blind peer review.
