Language of the Competition: English

Mode of Competition: Online mode

JUDGING CRITERIA

Participants will be judged on their ability to communicate their message effectively, their use of language, tone, and inflection, their confidence, and their overall presentation. Judges will evaluate each participant based on the following criteria: <u>Content</u> - The clarity and coherence of the message, the use of persuasive language and arguments, and the relevance to the topic.

<u>Delivery</u> - The use of tone, inflection, and body language to convey the message, the ability to engage the audience, and the overall confidence and presence of the speaker.

<u>Originality</u> - The uniqueness and creativity of the speech, the use of personal experiences and anecdotes to illustrate the message, and the ability to capture the audience's attention.

RULES FOR THE COMPETITION:

- 1. The elocution competition will take place in two rounds.
- July 21st & 22nd 2023 Round 1 will be a preliminary qualifying round and the winners will qualify for Round 2.
- **Round 2** will be the main round. The shortlisted candidates, as per Jury's decision will be eligible for Round 2. The date of round 2 will be notified later.

2. The participants will be given a topic 10 minutes before their turn on which he/she will have to speak and express opinion. Any topic from the broad list given below may be given to the elocution.

3. Each participant will be given a time limit not exceeding 08 minutes to speak on the subject. A warning bell will be given after 6 minutes and a final bell after 08 minutes. If the participants exceed the allocated time than the marks will be deducted at the discretion of the judges.

4. The decision of the judges as regards the result of the competition will be the final and binding.

5. The organizers reserve the right to take appropriate action for any unethical, unprofessional and immoral conduct

6. The organizer's decision regarding interpretation of rules or any other matter related to competition will be final.

7. If there is any situation not contemplated in the rules, the organizer's decision on the same shall be final.

8. A five-digit Unique code shall be mailed to the participants whose registration has been completed.
