Abstract: Not more than 300 words and a minimum of relevant 5 keywords

Paper: Co-authorship is permitted to a maximum of one author. However, both authors need to register separately. In the case of co-authorship, at least one author must attend the conference to present the paper. No Proxy presentations are allowed. Both author and co-author need to pay separately.

Maximum Length: 6000 words including title/cover page and references

Margins: 1" on all sides

Regular Font: Times New Roman, 12 points, Line spacing 1.5 justified **Title Font:** Times New Roman, 14 points, bold, Line spacing 1.5

Footnotes: Times New Roman, font size 10 with a spacing of 1.0

Citation: Bluebook 20th Edn. **Similarity:** Should not exceed 15%
