Original manuscript not exceeding length of 4000 words (including tables/ figures/ images) or maximum 10 pages. Normal margin setting must be used.
- Full name(s), designation, affiliation of the author(s), Contact No. & E-mail ids must be provided in the cover letter. In the covering letter accompanying the manuscript, the contributors should certify that the manuscript has neither been published anywhere nor it is at present being considered anywhere for publication.
- Abstract should be of maximum 200 words. Manuscript must be formatted in Times New Roman font style in 10-point font size, justified with single line spacing on MS Word.
- APA style of citation and referencing must be followed.
