Mooting helps in the overall development of an individual as a good and proficient lawyer and participating in Moot Court Competition regularly makes a student familiar with the proceedings that take place generally in real courtrooms. The advantages of mooting include: Research and Writing Skills, Practical Knowledge, Team Work and Communication Skills.

The National Moot Court Competition organized by SNSL, RRU aims to bring together some of the finest and brightest law students in India who are inclined towards Criminal and Security Laws.

In consonance with the aim of the Rashtriya Raksha University to create a cadre of legal professionals who are dedicated to the cause of security and law enforcement, the 1st RRU National Moot Court Competition shall be the first-of-its-kind in India to focus on the domain of national security and criminal justice.

Theme

- India is one of the top economies of the world, powered by digitization and the advent of technology. Similarly, every nation state is striving hard to achieve the said status, and on the path leading to it all these global entities are facing a spike in financial fraud and increased terror financing. There is a global consensus to give impetus to the economic and financial security of every nation, and India is leaving no stone unturned for ensuring the same.
- Accordingly, the Competition has been themed on the Economic and Financial Security of India dealing with allied aspects of terror financing, and misuse of technology, so as to promote a detailed thought process to address the current and upcoming challenges in the said domain. Thus, promoting policy discussion on financial security by way of this moot court competition, shall not only address India's demand to be an economically secure nation but shall also lead to tangible outcomes and policy discussion with respect to the global economy.

Who Can Participate?

- The Competition is open to all students, enrolled bona fide on a regular basis in an under graduate law course (Three Year Course / Five Year Integrated Course) conducted by any recognized College / Institution / University.
- A recognized College / Institution / University is entitled to send a maximum of 1 team to the competition.
- Each team shall comprise a minimum of two members and a maximum of three members. In a team comprising of two members, both members shall be designated as Orators. In a team comprising three members, two members shall be designated as Orators and the third member shall be designated as a Researcher.
- Teams shall not disclose their identity or that of their institution. However, the speakers can disclose their names only to the bench during the oral arguments.
- The accommodation arrangements to be provided on payment basis, shall only be provided to the students, and not any coach or accompanying faculty.
