 - II. Footnotes should be in Times New Roman, 10-font size with 1.0 line spacing.
 - III. Endnotes and/or Bibliography and in-text citations are not allowed.
 - IV. Headings should follow the following standard:
 - a. TITLE OF THE SUBMISSION: Upper-case, bold, font size 14
 - b. HEADINGS: Upper-case, bold, font size 14
 - b. Sub-Headings: Title-case, bold, font size 12
 - c. Sub-Sub-Heading: Title-case, italics, font size 12
 - V. The submission must be the original work of the author and must not have been submitted elsewhere or pending review.
 - VI. Co-authorship is allowed. The maximum number of co-authors for a submission shall only be one.
6. Kindly use footnotes only, Footnotes should conform to the Indian Law Institute, New Delhi Citation Style of Footnoting.
7. All submitted papers will go through a peer review process.
8. **The Law Mantra Trust retain all copyright.**

9. The manuscript should be accompanied with the author's name, designation, name of institute, contact number and e-mail for future reference and correspondence.
