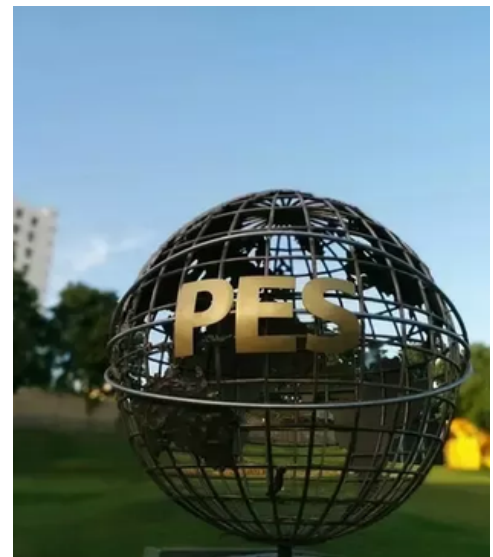

## Submission Guidelines

### ABSTRACT

The abstract shall be a minimum of 150 words and shall not exceed 300 words. It must be accompanied by a cover page, containing the following details: Title of the Paper and Sub-Theme, Name of the Author(s), Name of the Institution (if applicable), E-mail Address and Contact number.

### MANUSCRIPT

- Co-authorship is permitted to a maximum of two authors. In case of co-authorship both the authors need to be physically present on the day of the seminar.
- No Proxy presentations will be allowed.
- The manuscript must be accompanied with the following details: A cover letter mentioning the Name of the Author(s), Course, Year of Study and Name of the College/University(if applicable), Email Address and Contact Number.

## Submission Guidelines

### FORMATTING GUIDELINES

- The main text should be in Times New Roman, Font Size 12, Line Spacing 1.5
- The footnotes should be in Times New Roman, Font Size 10, Line Spacing 1.0
- One-inch margins should be maintained on all four sides
- Citation Style: Bluebook – 20th Edition
- All the submissions are to be made in Microsoft Word (.doc) and PDF format
- The word limit is 2500 to 4000 words

### MODE OF SUBMISSION

All submissions for the seminar have to be electronically mailed with the subject as “Submission of Abstract/Paper Title”, as the case may be, and bearing the name(s) of the author(s) as the file names, only at the following addresses:
