

Violence against women is a complex and multi-dimensional phenomenon, and over the years, there have been a number of theoretical approaches that have attempted to explain this complexity.


The United Nations defines violence against women as "any act of gender-based violence that results in, or is likely to result in, physical, sexual, or mental harm or suffering to women, including threats of such acts, coercion or arbitrary deprivation of liberty, whether occurring in public or in private life."

Violence against women occurs throughout the life cycle from prebirth, infancy, childhood, adolescence, adulthood to old age and is likely to occur anywhere like workplace, political sphere, cyber space etc.

As per World Health Organization (WHO) findings about 1 in 3 (35%) women worldwide have experienced either physical or sexual intimate partner violence or non-partner sexual violence in their lifetime.

Violence against women, particularly intimate partner violence and sexual violence, is a major public health problem and a violation of women's human rights. Globally, 38% of murders of women are committed by a male intimate partner.

Violence negatively affects women's general well-being and prevents them from being full time contributing members to the society. It impacts their families, their community, the country and the international sphere at large. The costs for treating and mitigating are tremendous and expand from greater strains on health care to legal expenses and losses in productivity.



#### **THEME**

At least 155 countries have passed laws on domestic violence, and 140 have legislation on sexual harassment in the workplace. However challenges remain in enforcing these laws, limiting women and girls' access to safety and justice. Not enough is done to prevent violence, and when it does occur, it often goes unpunished and sometimes even unrecognized.

A woman's right to live free from violence is upheld by international agreements such as the Convention on the Elimination of All Forums of Discrimination against Women and the 1993 UN Declaration on the Elimination of Violence against Women.

Only 40 percent of women seek help of any sort after experiencing violence, and so we wish to open the forum to understand the numerous causes and come out with solutions to try and put an end to this gender-based violence.

The United Nations General Assembly has designated November 25 as the International Day for the Elimination of Violence Against Women. The premise of the day is to raise awareness around the world that women are subjected to rape, domestic violence and other forms of violence; furthermore, one of the aims of the day is to highlight that the scale and true nature of the issue is often hidden.

In order to raise awareness, discuss pertinent challenges and the possible solutions on the socio-legal aspect of violence against women, Army Law College, Pune is conducting this seminar to discuss opinions of various professionals, academicians, students and people from different spheres of life. The discussion will further enlighten the knowledge of the audience on the subject matter and help us formulate solutions to this seemingly ever lasting problem.

Only selected abstracts will be permitted for presentation.


ABSTRACT: The abstract should not exceed 300 words and must be accompanied by a cover page stating the following: -

- Name and Designation of the author (s) E-mail address
- Postal address and Contact Number

#### FULL RESEARCH PAPER: The following guidelines should be followed:

- The word limit of the paper shall be 5,500-8,500 words (exclusive of footnotes)
- The main text of the full paper should be in Times New Roman with a font size
   12 and line spacing of 1.5.

Profile and identification for all individual authors and for both the authors is a mandate in case of co-authorship.



### **GUIDELINES FOR SUBMISSION**

- The footnotes should be in Times New Roman, font size 10 with spacing of 1.0 (Endnotes are not permitted).
- One-inch margins should be maintained on all four sides of the pages.
- Citation Style: Bluebook, 20th edition.
- Co-authorship is permitted to a maximum of two authors and at least one author must attend the Conference to present the paper.
- No proxy presentations will be allowed.
- All submissions must be the author's original and unpublished work. Any amount of Plagiarism will attract immediate disqualification.
- Full paper with the subject as "Submission of Full Paper" must be submitted through E-mail at armylawcollegepune.seminar@gmail.com
- The plagiarism report should be less than 10%, softwares like turnitin will be used for the same
- All the papers will be peer reviewed by a committee of experts with respect to their quality, originality, and relevance.
- All authors/coauthors will have to register and a co-authorship up to two persons is allowed.
- Certificate of originality has to be submitted with the full paper.
- All rights of publication of papers presented in the Seminar shall rest with the Seminar organizers.




# MODE OF PRESENTATION




