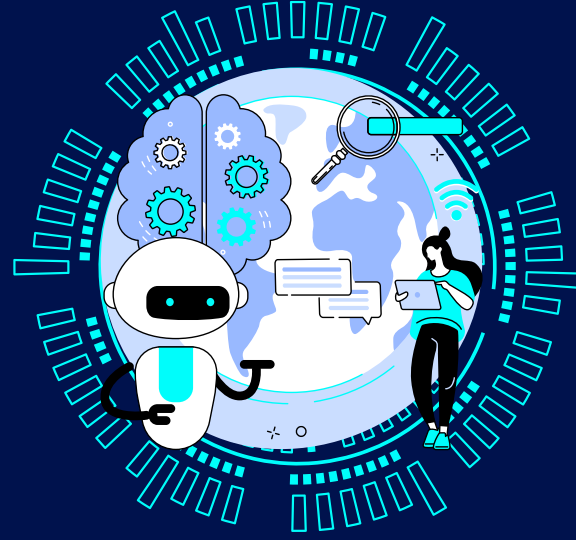

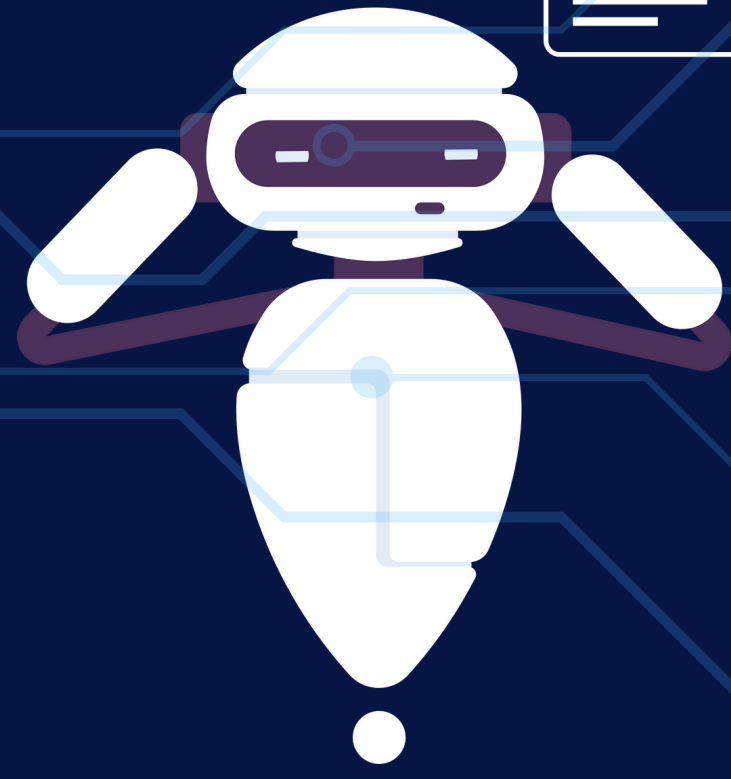

- FINANCIAL CYBERCRIME LEGISLATION AND ENFORCEMENT;
- ANALYZING THE ROLE OF POLICYMAKING IN REGULATING THE METAVERSE;
- ROLE OF TECHNOLOGY IN CRIMINAL INVESTIGATION AND FORENSICS;
- POTENTIAL OF TECHNOLOGY TO IMPROVE ADMINISTRATION OF CRIMINAL JUSTICE;
- IMPACT OF CYBER SECURITY LEGISLATIONS IN INDIA ON VARIOUS ASPECTS OF CRIMINAL JUSTICE SCIENCES;
- THE CONCEPT OF CYBER VICTIMOLOGY AND ITS ROLE IN ADMINISTRATION OF CRIMINAL JUSTICE.

THE ABOVE THEMES AND SUB-THEMES ARE MERELY INDICATIVE IN NATURE AND NOT EXHAUSTIVE. PARTICIPANTS MAY SUBMIT AN ABSTRACT ON ANY CONTEMPORARY, RELEVANT, AND CONNECTED ISSUE OF THE INTERSECTION OF CRIMINAL JUSTICE ADMINISTRATION WITH TECHNOLOGY.

THE CONFERENCE IS SCHEDULED TO BE HELD ON **FEBRUARY 03 & 04, 2024**. THE CONFERENCE WILL FEATURE PLENARY SESSIONS, PANEL DISCUSSIONS, PAPER PRESENTATIONS, AND INTERACTIVE SESSIONS AMONG THE PARTICIPANTS, JUDGES, SPEAKERS AND ATTENDEES.

THIS CONFERENCE IS AIMED AT STUDENTS, RESEARCHERS, ACADEMICIANS AND PRACTITIONERS IN THE AREAS OF CRIMINOLOGY, VICTIMOLOGY, LAW, SOCIOLOGY, INFORMATION TECHNOLOGY, AND ALLIED SCIENCES, CRIMINAL JUSTICE PROFESSIONALS, NGO PRACTITIONERS, AND EXPERTS IN THE FIELDS OF CYBER-CRIMES, INFORMATION SECURITY AND DIGITAL FORENSICS. THE CONFERENCE WILL HAVE A BALANCE OF LECTURES AND PRESENTATIONS FROM THE ACADEMIC AS WELL AS THE PRACTITIONERS' PERSPECTIVES. IT IS AIMED AT CREATING A PLATFORM FOR A HEALTHY EXCHANGE, DEBATE AND DEVELOPMENT OF IDEAS AND EMERGING ISSUES IN THE AREA OF LAW AND TECHNOLOGY AND ITS ROLE IN THE CRIMINAL JUSTICE SYSTEM.

CALL FOR SUBMISSIONS

RESEARCH PAPERS ON THE ABOVE THEME AND SUB-THEMES ARE INVITED FROM FACULTIES, RESEARCHERS AND STUDENTS IN THE FIELDS OF CRIMINOLOGY, VICTIMOLOGY, LAW, SOCIOLOGY, INFORMATION TECHNOLOGY, AND ALLIED SCIENCES, FROM CRIMINAL JUSTICE PROFESSIONALS, NGO PRACTITIONERS, AND FROM EXPERTS IN THE FIELDS OF CYBER-CRIMES, INFORMATION SECURITY AND DIGITAL FORENSICS. AN ABSTRACT OF THE PAPERS TO BE PRESENTED WITH NOT MORE THAN 300 WORDS SHOULD BE SUBMITTED ON OR BEFORE 1ST DECEMBER 2023. AFTER THE ACCEPTANCE OF THE ABSTRACT, THE FULL PAPER SHOULD BE SUBMITTED ON OR BEFORE 15TH JANUARY 2024. THE ABSTRACT AND THE FULL PAPERS SHOULD BE SENT VIA A GOOGLE FORM.

GCRCJS BEST PAPER AWARD

THE GCRCJS BEST PAPER AWARD WILL BE GIVEN FOR THE BEST THREE RESEARCH PAPERS OF THE CONFERENCE ACROSS ALL THE SESSIONS. THE BEST PAPERS WILL BE CONSIDERED FOR PUBLICATION AS WELL.

ABSTRACT IS TO BE SUBMITTED VIA GOOGLE FORM WHICH CAN ALSO BE ACCESSED ABOVE. THE PARTICIPANTS ARE REQUESTED TO SUBMIT AN ABSTRACT OF A MAXIMUM OF 300 WORDS IN MICROSOFT WORD DOCUMENT, FONT STYLE – (ITALIC) TIMES NEW ROMAN, FONT SIZE – 12, LINE SPACING – DOUBLE. THE ABSTRACT MAY INCLUDE KEYWORDS (MAXIMUM: FIVE). THE ABSTRACT MUST INCLUDE A CLEAR INDICATION OF THE OBJECTIVES, METHODOLOGY, MAJOR RESULTS, IMPLICATIONS, AND KEY REFERENCES. ALL ABSTRACTS WILL BE SUBJECT TO BLIND REVIEW AND ONLY THOSE ABSTRACTS APPROVED BY THE REVIEWERS WILL BE SELECTED TO SUBMIT THEIR COMPLETE PAPER FOR THE FINAL PRESENTATION. THE CRITERIA FOR EVALUATION BY THE REVIEWERS ARE BASED ON RELEVANCE, METHODOLOGY AND ORIGINALITY.

PAPER GUIDELINES

- NAME OF THE AUTHOR(S) OR ANY OTHER FORM OF IDENTIFICATION MUST NOT BE MENTIONED IN THE RESEARCH PAPER.
- CO-AUTHORSHIP IS LIMITED TO A MAXIMUM OF TWO (2) AUTHORS. BOTH THE AUTHOR AND CO-AUTHOR HAVE TO BE PRESENT TO PRESENT THE PAPER IN ORDER TO BE ELIGIBLE FOR THE CERTIFICATE.
- WORD LIMIT: 3000 – 4000 WORDS, EXCLUDING FOOTNOTES, INDEX, AND BIBLIOGRAPHY
- FONT STYLE – TIMES NEW ROMAN
- FONT SIZE – 14 FOR HEADINGS, 12 FOR BODY, 10 FOR FOOTNOTES
- LINE SPACING – 1.5 FOR BODY, 1.0 FOR FOOTNOTES
- CITATION STYLE – OSCOLA
- MARGINS – 1 INCH (I.E., 2.54 CM) ON EACH SIDE
- NOTE: SPEAKING FOOTNOTES ARE ALLOWED IN THE SUBMISSIONS BUT ARE NOT MANDATORY.
- PLAGIARISM LIMIT IS 10% IN ACCORDANCE WITH UGC GUIDELINES.
- USE OF ARTIFICIAL INTELLIGENCE FOR SUBMISSIONS IS STRICTLY PROHIBITED AND HIGHLY DISCOURAGED.
- THE ABSTRACTS THAT ARE SELECTED FOR THE FINAL PAPER PRESENTATION WILL BE PROVIDED THE FINAL PAPER SUBMISSION LINK VIA EMAIL.

REGISTRATION DETAILS

HOW TO REACH GNLU

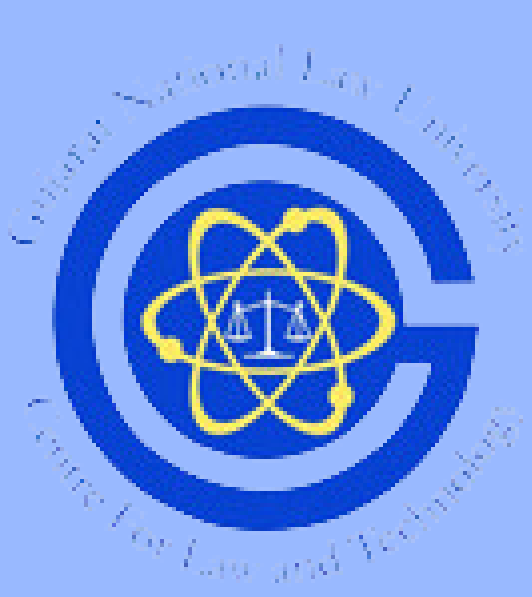

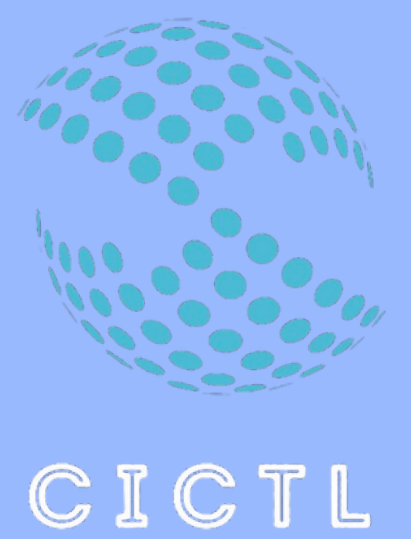
