Mohapatra joined as its first Hon'ble chairperson. Present chairman of the OHRC is Justice Satrughana Pujari. The Commission mainly enquires into violation of Human Rights by a public authority, namely; rights relating to life, liberty, equality and dignity of the individual guaranteed by the Constitution or embodied in the International Covenants and enforceable by Courts in India, and issues appropriate direction necessary for the protection of such rights.

#### **ABSTRACT SUBMISSION GUIDELINES**

- 1. Abstract should be submitted to lcchr.seminar@gmail.com
- 2. Each applicant must submit a maximum 250 words abstract not later than **December 10th**, 2023,
- 3. The abstract must contain a brief profile of the author/s indicating his/her email ID, contact number, designation, and official email address.
- 4. Maximum of 5 keywords are to be provided along with the abstract
- 5. Co-authorship allowed up to two authors only.
- 6. The decision of the screening committee regarding the selection of the abstract for the conference shall be communicated and final.

#### **FULL PAPER SUBMISSION GUIDELINES**

- 1. Last date for submission of Full Paper is 28th December 2023
- 2. Selected abstracts will be notified for full paper submission.

  Details will be provided in the response mail indicating selection.
- 3. The full-length paper should not exceed 4000-6000 words including footnotes and references. It must have the abstract and details of the authors.
- 4. In the event of co-authorship at least one author must attend the seminar to present the paper.
- 5. The main text should be in Times New Roman with font size 12 and spacing of 1.5 and Margin-1 inch on all sides, page size A4. Footnotes in size 10.
- 6. Spelling: UK- except in quoted text, which will follow the original spelling.
- 7. All submissions must be the author's unpublished and original work and should not exceed the similarity index of 10%
- 8. Referencing and Citation style is Bluebook (20th edition).
- 9. Style for headings- Chapter Title: All in Caps, bold, centred.
- 10. Style for Subheadings:
  - Level 1: Heading style capital, bold, left aligned, underlined.
  - · Level 2: Headline style-bold, italics, left aligned.
- Level 3: Headline style italics, left aligned.
- 11. The paper must be submitted in word document [doc or .docx) format only.
- 12. Full paper should contain: Introduction, Review of Literature, Research Methodology, Analysis/Discussion, Conclusion and References.


