Submission Guidelines

GCHRJ requests that the contributors comply with the following guidelines:

All manuscripts should be original and should not be simultaneously considered by any other publication.

The journal accepts manuscripts for publication on a rolling basis throughout the year. Please refer to the website for final submission dates for the next edition.

Length Limitations

Manuscripts may be submitted under the following categories:

1. **Long Manuscripts:** Between 5000 and 8000 words, inclusive of references. Manuscripts in this category are expected to engage with the theme and literature comprehensively and offer an innovative reassessment of the current understanding of that theme. It is advisable, though not necessary, to choose a theme that is of contemporary importance and in the area of the journal's focus. Purely theoretical pieces are also welcome.
2. **Short Manuscripts:** Between 1500 and 3000 words, inclusive of references. Short Manuscripts are far more concise in scope. These manuscripts usually deal with a very specific issue and argue that the issue must be conceptualised differently. They are more engaging, and make a more easily identifiable, concrete argument. Authors can focus on Human Rights Education at Universities and specific manuscripts can be submitted on education programmes, academic freedom, research, methodology, teaching, etc. Manuscripts on the role of the university in democracy, human rights, environment, etc. are also preferred.
3. **Review Essays, Book Reviews, and Reviews in General:** Reviews should focus on texts published in the past three years; older books may be accepted if the author can justify why a review would be timely and a good fit for the journal. Review essays can be made of multiple books. Reviews of films, exhibitions, multimedia, and other media related to human rights and democracy will be accepted. Reviews inform readers about current advances in the field and encourage productive discourse. Submissions should be less than 1,500 words in length (up to 3,000 words for review essays), describing the book's arguments and providing a critical analysis of its strengths and weaknesses.

Manuscript Submission

1. GCHRJ only accepts electronic submissions. Submissions have to be sent through email at gcjournal@gchumanrights.org. We cannot accept manuscripts submitted in any other way.
2. Include an assurance that the article has not been published, submitted, or accepted elsewhere.
3. Conform to the style conventions of the journal (see below).
4. Be written in UK English.
5. Submissions should include an abstract (summarizing the article, including its aim, a clear description of its findings) of between 250 and 300 words. The abstract should include at least five key words.
6. Include a brief biography indicating academic qualifications and current professional position, and email contact address, as follows: Indira Ntuli; BA (UNTL), PhD (Sao Paolo); Visiting Professor, University of Sao Paolo; name@email.address
7. Times New Roman, 12 pt, 1.5 spacing, 1-inch gap on all four sides.
8. We will accept articles for review in another referenced style on the understanding that the author will reformat the article during the review process. Please see the annexed style sheet for details.



Plagiarism

All the contributions should be the original work of the contributors and should not have been submitted for consideration in any other journal. All contributions will be put through plagiarism check software and any plagiarised work will be automatically rejected.

Editorial Process

All submissions are reviewed initially by the editors and may be rejected by them on the basis of focus, style and depth of analysis and research. Screened submissions are subjected to peer review by at least two experts in the field.

The Bibliography of the Global Campus Journal must conform with the Author-Date system of the Chicago Manual of Style (as stipulated in the GCHRJ Call for Submissions).

Authors must follow these requirements:

1. Please use consistently British English spelling.
2. Sentence-style capitalisation (i.e. capitalise only the first word of a sentence or phrase and proper nouns)

4. We are moving away from having the long and meaningless lines of URLs in the paper and hiding them with a hyperlink. Can authors convert URLs in the bibliography to a hyperlink using the text Link. Here is what it looks like:
