 - e. **Line spacing: 1.5**
 - f. **The Cover page shall consist of the following details: Title of the Paper, Name of the author(s), Official designation/institutional details, Address, E-mail Id and Contact details of the Author(s).**
 - g. **The subject of E-mail for submission of Abstract must be "National Seminar: Submission of Abstract & Cover Page.**
 - h. **There must be a single file containing the cover page and abstract.**
