Submission Guidelines

- 1. All submissions are to be made in English.
- Scholars, Researchers, Practitioners, Academicians and Students pursuing five year LLB or three year LLB or any under/post graduate degree programmes are eligible to send their abstracts on issues related to the above themes.
- 3. Authors of selected papers will be given an opportunity to present their papers in the conference.
- 4. Joint authorship is permitted, subject to a maximum of two co-authors.
- 5. Authors are required to do the individual registration.
- 6. Upon approval through a peer reviewing process, the best papers shall be published in a book with ISBN.

- 7. A brief profile of the author indicating his/her designation, email ID, contact number and address has to be sent along with the abstract (250-300 words) of the paper to the Organizing Committee. The abstracts should be emailed to conferencelawtechnology@ncuindia.edu
- 8. Once the payment has been made, please take a screenshot of the transaction reflecting the transaction ID including UPI Reference Number. and email it along with the scanned copy of the registration form to conferencelawtechnology@ncuindia.edu
- 9. The Full-Length Paper should not exceed 6000 words excluding footnotes. It should be typed in Times New Roman Font Size 12 with 1.5" line spacing and 10 pt. for the footnotes on A4 size paper with 1" margin on all sides using MS Word. Use of ILI style of referencing and footnoting is to be followed.
- 10. Outstationed and international presenters' opportunity will be given to them to present their papers in Virtual mode subject to the production of proof
